We discussed new laptops with so much of what we do being online. I spoke of the rotation schedule within the building, however, I'm unsure where we fall within the schedule. I informed them of the addition of Career Safe OSHA training this year for our class. They are all in agreement that many exceptional things going above & beyond are happening in Cosmetology. They were elated with the amount of guest speakers we had in to present to our class & the 4 still slated before the year ends. They discussed the continued need for the program & its importance to our local industry. This has been a big year for co-op experiences for our students. They loved that							

FCCTC can now offer our state board exam for Pearson Vue & were grateful Mrs. Parson suggested that possibility to get it rolling. Currently 13 of our 20 seniors are working in industry. They were also very pleased at the adult enrollment (23) for cosmetology, nail tech, teachers & esthetic's licenses. They applauded Mrs. Parsons dedication to the program/school & commented on the amount of extra work that is involved with the adult population. They want to see the current financial set-up continue between adult education & Cosmetology. Many scenarios were looked at, but they feel the current one is the most beneficial & fair to all. This is a valuable piece to the school & the community. This was a wonderful meeting with so much information gleaned between members.

• Administration would agree there is no shortage of good things happening in Cosmetology. The program performs well, looks good and is attracting successful students. We are pleased with the variety of guest speakers and professionals that the instructors have invited in to share industry expertise with the students. Continue this as we see fit & have the availability in enrollment. Secondary enrollment is always the priority. They want the current financial set-up to continue between adult education & Cosmetology. Many scenarios were looked at, but they feel the current one is the most beneficial & fair to all & ultimately provides significant savings to the school. We had 23 adult students this year in addition to the high school ones & currently have 5 scheduled for fall of 2023. This is a valuable piece to the school & the community.

- They liked the current student kit (actual case) and how it's helping to keep the school costs down with the students purchasing that on their own. It has taken \$40 off of the school expense side.
- Complimented Mrs. Fore and me on how we are serving our students and laying the groundwork for them to be productive citizens and value our industry.
- Applauded the effort from our many substitutes that we have and especially Alison Cook, Kimberly Norton, Mariah Mazzarella and Michele Myers for graciously helping while Mrs. Fore is on maternity leave for the remainder of the year. It's been a great year having so much support from our OAC members and leadership team at FCCTC.
